Preferred Method is Online – No Voucher Needed

ONLINE 2025 TRUST TAX LIABILITY PAYMENT INSTRUCTIONS:

Payments for your federal and Indiana trust tax liability may be made online via the websites below. For proper application, be sure to select the appropriate payment type (**fiduciary/trust**) and tax year (**2025**).

Electronic payments to the IRS

- **Payment from a bank account - no charge - Uses Electronic Federal Tax Payment System (EFTPS)**

Payments must be scheduled at least one calendar day prior to the tax due date (before 8:00 pm ET).

- Select "Make a Payment" and Log in with your EIN, PIN, and Internet password
- Payment Selection will be Fiduciary/Trust Tax Liability Payment
- Enter payment information in the step-by-step screens.
- Once finished, save a copy of the Payment Confirmation page. This contains your EFT Acknowledgment Number that acts as a receipt for your payment instructions

- **Payment from debit or credit card - various charges apply, select an option**

- Payment Category: Business taxes (Form 1041)
- Selections vary: Based on processor
- Tax Year: 2025 (current tax return)
